Depp wins out in bitter Heard defamation trial

Jury sides with Johnny Depp in libel case against ex-wife Amber Heard, awards him \$10M

AFP | Los Angeles

US jury found both Johnny Depp and his ex-wife Amber Heard liable for defamation - but sided more strongly with the "Pirates of the Caribbean" star following an intense trial riding on bitterly contested allegations of domestic abuse.

The verdict capped a bitterly-fought six-week trial riding on lurid claims and counterclaims of between the Hollywood celebrities.
