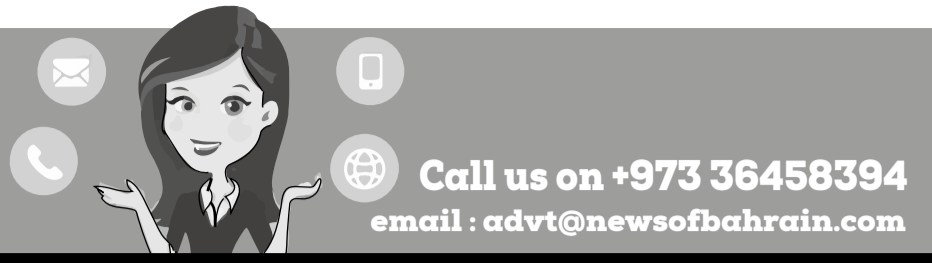

Top seed Alcaraz reaches first Wimbledon semi-final

Carlos Alcaraz saw off Holger Rune in straight sets yesterday to stay on course for a Wimbledon title showdown against defending champion Novak Djokovic.

The top seed won the key moments during the quarter-final on Centre Court to progress 7-6 (7/3), 6-4, 6-4 and will play Russian third seed Daniil Medvedev in the semi-finals. The Spaniard faced just one break point in the entire match, which he snuffed out, hitting 35 winners against 13 unforced errors.

"Honestly, it is amazing for me," said Alcaraz after beating his friend. "It's been a dream since I started playing tennis."

The US Open champion, who now has 10 straight wins on grass, was delighted with his performance against his fellow 20-year-old.

The start of the breaker was tight but Rune's double-fault gave Alcaraz a 4/3 lead and he won the next three points to take the first set.

It was a similar story in the second set until Rune dumped a forehand smash into the net in the ninth game to give the Span-

iard break point.

Alcaraz made no mistake, smoking a backhand down the line to break and holding with ease to move two sets up.

He broke again in the fifth game of the third set, giving Rune a mountain to climb.

The Danish star saved one match point on his own serve but was powerless to stem the tide as Alcaraz served out to reach the last four at the All England Club for the first time.

The Serbian faces Italian eighth seed Jannik Sinner in Friday's other semi-final. Alcaraz is aiming to become the third-youngest player to win the Wimbledon men's singles crown in the Open Era. If he captures his second major at the All England Club, he is guaranteed to remain as world number one.

Ashwin's double strike puts West Indies in trouble

Ravichandran Ashwin made an immediate impact with two wickets on his return to Test cricket as India reduced the West Indies to 68 for four at lunch on the first day of the opening Test in Dominica yesterday.

Omitted for the World Test Championship final against Australia a month earlier, the 36-year-old spinner removed openers Tagenarine Chanderpaul and Kraigg Brathwaite having being brought into the attack after just 40 minutes' play on what looked a placid pitch offering little assistance for the faster bowlers.

However seam bowling all-rounder Shardul Thakur then had Raymon Reifer caught behind in his first over

while Jermaine Blackwood's luck ran out when he was brilliantly caught by a leaping Mohammed Siraj at mid-off to the bowling of Ashwin's spin partner Ravindra Jadeja in what proved to be the final ball before the interval.

Blackwood was dropped first ball off Ashwin by wicketkeeper Ishan Kishan, one of two debutants for the Indians, the other being 21-year-old Yashvi Jaiswal, selected to open the batting with captain Rohit Sharma.

Sharma's opposite number, Brathwaite, will be regretting his decision to bat first at this stage as the home side resumes in the afternoon session with local boy and debutant, Alick Athanaze (13 not out) seeking to impress against a confident Indian side.

Messi mulls international retirement, but not quite yet

Argentina World Cup winning captain Lionel Messi says he has no idea when he will finally call time on his international career.

"Even I don't know when. It'll happen when it happens," the 36-year-old said in an interview broadcast on Argentine television on Wednesday.

"After winning everything I want to enjoy the moment and wait for time to tell me when it's the moment," said the seven-time Ballon d'Or winner.

"Logically, given my age, one would expect it to be soon, but I don't know for sure.

"Now that we are American champions (Argentina won the 2021 Copa America) and world champions we have to enjoy that."

He reiterated earlier comments that he was unlikely to be in Argentina's squad when they defend their World Cup title in 2026.

The interview was conducted in China last month, when Messi scored the quickest goal of his career after just 79 seconds in a 2-0 friendly win against Australia in Beijing.

On Tuesday, Messi arrived in Florida to put the final touches on his move to US Major

League Soccer club Inter Miami from Paris Saint-Germain.

He is expected to put pen to paper on a two-and-a-half year deal, reported to be worth \$60 million a year,

before being presented to fans at a stadium event on Sunday.
